- 6" Structural channel gusseted main rails.
- Fire suppression access at the top of each side.
- 10"x 8" Stationary steel wheels with grease fittings.
- Interior and exterior coated with rust inhibitive alkyd primer.
- Exterior painted your choice of standard color with alkyd enamel paint. Some colors may be extra.
- Bottom coated with automotive underseal.






TIE BACK LOCATION




REAR/DRIVER'S SIDE
